The "A YEAR OF THE HORSE: ULTIMA LUNAR PROSPERITY" is offered by Ultima Markets Ltd (Mauritius license No. GB 23201593) (here in "the Company or "Ultima Markets") to the Company's clients (here in "the Client" or "client").

DURATION

This Campaign is valid from 12th January 2026 00:00 (GMT +3) to 20th February 2026 at 23:59 (GMT +3).

TERMS AND CONDITIONS

1. The Promotion is available to all Ultima Markets' Clients who resides in Indonesian only.
2. Ultima Markets reserves the right to request additional documentation or verification to confirm a client's country of residence. Clients found to be residing outside Indonesia will be disqualified from the Promotion.
3. Clients must be at least eighteen (18) years of age to participate in this Promotion.

ACCOUNT ELIGIBILITY

4. To participate, a client must:
 - a. Register with Ultima Markets; and
 - b. Successfully complete the Know Your Customer (KYC) verification process.
5. The Promotion is applicable to Live Standard trading accounts only. Other account types are excluded.
6. Clients whose accounts are linked to Cent Account, PAMM, MAM, or Social Trading services are not eligible to participate in this Promotion.
7. Clients must opt in to the Promotion via the designated promotion section on the Ultima Markets landing page and select the participating trading account before the relevant Cycle begins. Once selected, the trading account cannot be changed during the Cycle.

DEPOSIT REQUIREMENT

8. To participate in the Promotion, clients must make a minimum net deposit of USD 500 into the selected Live Standard trading account during the Promotion Period.
9. "Net Deposit" refers to the total deposits minus total withdrawals made within the same cycle.

ELIGIBLE INSTRUMENT

10. Only trading volume generated from the following instruments will be counted toward the promotion requirements:

- a. Forex Major currency pairs
 - b. Forex Minor currency pairs
 - c. Gold (XAUUSD)
11. Trading volume generated from any other instruments will not be included in the calculation of Angpao eligibility or rewards.

REWARD STRUCTURE & ANGPAO ELIGIBILITY

12. Angpao rewards are unlocked based on the trading volume (standard lots) completed within each individual cycle, subject to the applicable minimum trading requirements as determined by the Company.
13. All eligible clients begin at the same entry level, with no reward tier differentiation based on net deposit size beyond the minimum USD 500 requirement.
14. Each client is entitled to receive one (1) Angpao reward per cycle only, provided all conditions are met.
15. Angpao rewards cannot be accumulated, transferred, or carried forward to subsequent cycles.

18. Trading volume must be completed on eligible instruments within the same cycle to qualify for the corresponding Angpao reward tier.

PARTICIPATION MECHANICS

19. Client registers for the Promotion and selects one (1) Live Standard trading account.
20. Client makes a minimum deposit of USD 500.
21. The system displays the client's Angpao eligibility status as pending for the relevant cycle.

22. Client completes the required minimum trading volume on eligible instruments within the cycle period.
23. Withdrawals are permitted during the cycle; however, withdrawals will reduce the Net Deposit and may affect eligibility.
24. At the end of each cycle, the company calculates:
 - a. Final Net Deposit (total deposits minus total withdrawals); and
 - b. Total eligible trading volume completed within the cycle.
25. If all conditions are satisfied, the Angpao reward will be credited to the client's trading account within the designated crediting period after verification.
26. Each new cycle starts independently, and eligibility is recalculated based on the remaining Net Deposit.

TRADING RULES & RESTRICTIONS

27. A minimum holding time of two (2) minutes per trade is required for all trades counted toward the Promotion.
28. Hedging between multiple accounts is strictly prohibited.
29. Any form of abusive, manipulative, or irregular trading behavior, including but not limited to churning, scalping spikes, latency arbitrage, toxic order flow, or system exploitation, may result in immediate disqualification.
30. Participation is limited to one (1) client per verified identity, validated through KYC details, email address, phone number, device identification, and bank account information.
31. Duplicate, shared, or fraudulent account activity will result in immediate disqualification and forfeiture of all rewards.
32. The Company reserves the right, at its sole discretion, to determine whether any trading activity or behavior violates the intended purpose of the Promotion.

REWARD CREDITING AND WITHDRAWAL

33. Angpao rewards will be credited to the client's trading account after the end of each cycle, subject to verification.

40. New Live Accounts are subject to approval in accordance with Ultima Markets' account opening procedures.
41. Ultima Markets reserves the right to prohibit or restrict participation if deposits are made via certain payment channels, including e-wallets or cryptocurrency, where applicable.
42. Clients are strictly prohibited from using any Angpao reward, campaign reward, or promotional credit obtained from this Campaign to conduct hedging strategies or offsetting positions, whether within the same account or across multiple accounts. Ultima Markets reserves the right, at its sole discretion, to revoke a client's eligibility to participate in this Campaign, cancel any pending or credited rewards, and remove any profits derived from such prohibited trading activities without prior notice.

- a. Churning (opening and closing of Margin FX or CFD transactions just for the benefit of earning a benefit);

In the event of such misconduct or breach, Ultima Markets shall have the right to deduct any bonus amount from the trading account.

Ultima Markets may at any time make changes to these terms and conditions and will notify modify or cancel any offers at its sole discretion at any time. time and at its sole discretion. you of these changes by posting the modified terms on the Ultima Markets website. You are advised to review these Terms regularly and by your continued use of Ultima Markets website and services that you accept any such modified terms.
46. Ultima Markets reserves the right to cease or discontinue any of its campaigns, promotions and/or offers at any time and at its sole discretion.
47. If these terms and conditions are translated into a language other than English, the English version will take precedence if there is a difference between the two.
