## **DURATION**

This Campaign is valid from 4th May 2026 00:00 (GMT+3) to 31st May 2026 23:59 (GMT+3).

The actual campaign period shall be subject to the time displayed in the designated promotional campaign area.

## **ELIGIBILITY CRITERIA**

1. This Campaign is open to all existing clients of Ultima Markets. By participating in this Campaign, the client acknowledge that they have read and agreed to be bound by the Terms and Conditions herewith and Ultima Markets' General Terms and Conditions.
2. New clients are required to register an account with Ultima Markets prior to opt-in for this Campaign.
3. To become a new client of Ultima Markets, it is necessary to register with Ultima Markets, provide all relevant information upon request as part of "KYC" (Know Your Customer) process and create a Live Account.
